Application for Authority to Construct was made for: The installation of a Southern Breeze Eliminator SB-250 incinerator. This unit was installed without obtaining a construction permit. STANDARD CONDITIONS:

Permission to construct may be revoked if you fail to begin construction or modification within two years from the effective date of this permit. Permittee should notify the Air Pollution Control Program if construction or modification is not started within two years after the effective date of this permit, or if construction or modification is suspended for one year or more.

You will be in violation of 10 CSR 10-6.060 if you fail to adhere to the specifications and conditions listed in your application, this permit and the project review. In the event that there is a discrepancy between the permit application and this permit, the conditions of this permit shall take precedence. Specifically, all air contaminant control devices shall be operated and maintained as specified in the application, associated plans and specifications.

You must notify the departments' Air Pollution Control Program of the anticipated date of start up of this (these) air contaminant source(s). The information must be made available not more than 60 days but at least 30 days in advance of this date. Also, you must notify the Department of Natural Resources Regional office responsible for the area within which you are located within 15 days after the actual start up of this (these) air contaminant source(s).

A copy of this permit and permit review shall be kept at the installation address and shall be made available to Department of Natural Resources' personnel upon request.

You may appeal this permit or any of the listed special conditions to the Administrative Hearing Commission (AHC), P.O. Box 1557, Jefferson City, MO 65102, as provided in RSMo 643.075.6 and 621.250.3. If you choose to appeal, you must file a petition with the AHC within 30 days after the date this decision was mailed or the date it was delivered, whichever date was earlier. If any such petition is sent by registered mail or certified mail, it will be deemed filed on the date it is mailed. If it is sent by any method other than registered mail or certified mail, it will be deemed filed on the date it is received by the AHC.

If you choose not to appeal, this certificate, the project review and your application and associated correspondence constitutes your permit to construct. The permit allows you to construct and operate your air contaminant source(s), but in no way relieves you of your obligation to comply with all applicable provisions of the Missouri Air Conservation Law, regulations of the Missouri Department of Natural Resources and other applicable federal, state and local laws and ordinances.

SPECIAL CONDITIONS:

The permittee is authorized to construct and operate subject to the following special conditions:

The special conditions listed in this permit were included based on the authority granted the Missouri Air Pollution Control Program by the Missouri Air Conservation Law (specifically 643.075) and by the Missouri Rules listed in Title 10, Division 10 of the Code of State Regulations (specifically 10 CSR 10-6.060). For specific details regarding conditions, see 10 CSR 10-6.060 paragraph (12)(A)10. "Conditions required by permitting authority."

1. Particulate Matter (PM) Concentration Limitation
7th Heaven Crematory shall emit less than 0.9 grains per dry standard cubic feet of PM from the incinerator (EP-01).
2. Process Requirements for the Incinerator (EP-01)
 - A. 7th Heaven Crematory will burn exclusively pathological animal waste that is not medical/ infectious waste. These terms are defined in the project description.
 - B. Charging of waste between burn cycles is prohibited in the batch-type incinerator.
 - C. The incinerator shall be equipped with a continuous chart recorder that is able to monitor, display and record the temperature in the final combustion chamber to an accuracy of plus or minus two percent (2%).
 - D. The operators shall maintain the secondary chamber at a temperature of no less than the temperature at which the unit was operated during the compliance test for PM and combustion efficiency.
 - E. The incinerator shall have a minimum combustion efficiency of 99.9% determined from the carbon dioxide (CO₂) concentration divided by the sum of the carbon monoxide (CO) and CO₂ concentrations.
3. Record Keeping Requirements
7th Heaven Crematory shall maintain an accurate record of the monthly amount and type of waste combusted at this installation. The installation shall use Attachment A or other equivalent form(s) approved by the Air Pollution Control Program for this purpose. 7th Heaven Crematory shall maintain records on-site for the most recent 60 months of all records required by this permit and shall immediately make such records available to any Department of Natural Resources' personnel upon request.
4. Opacity
The incinerator (EP-01) shall have opacity of less than ten percent (10%) at all times.

SPECIAL CONDITIONS:

The permittee is authorized to construct and operate subject to the following special conditions:

5. Operator Requirements for the Incinerator (EP-05)
 - A. All incinerator operators shall attend a training program equivalent to that developed by the American Society of Mechanical Engineers (ASME), by the incinerator manufacturer or by an individual with more than one (1) year experience in the operation of the incinerator. The training shall include basic combustion theory, operating procedures, monitoring of combustion control parameters and all emergency procedures to be followed if the incinerator should malfunction or exceed operating parameters.
 - B. The incinerator operator shall have the essential steps necessary for satisfactory operation of the incinerator readily available to him or her in an easy to read and follow manual.

6. Compliance Testing
 - A. 7th Heaven Crematory shall demonstrate compliance with special condition 1 through testing.
 - 1.) Testing shall be conducted in accordance with 10 CSR 10-6.030 *Sampling Methods for Air Pollution Sources* paragraph (5)(A).
 - B. 7th Heaven Crematory shall demonstrate compliance with special condition 2.# through testing.
 - 1.) Testing for CO₂ shall be conducted in accordance with 10 CSR 10-6.030 paragraph (3).
 - 2.) Testing for CO shall be conducted in accordance with 10 CSR 10-6.030 paragraph (10).
 - C. A completed Proposed Test Plan Form (enclosed) must be submitted to the Air Pollution Control Program's Compliance/Enforcement Section, P.O. Box 176, Jefferson City, MO 65102 at least 30 days prior to the proposed test date so that the Air Pollution Control Program may arrange a pretest meeting, if necessary, and assure that the test date is acceptable for an observer to be present.
 - D. The test shall be conducted no later than 60 days after the unit has begun operation.
 - E. Two (2) copies of a written report of the performance test results shall be submitted to the Director of the Air Pollution Control Program within 60 days of completion of any required testing. The report must include legible copies of the raw data sheets, analytical instrument laboratory data, and complete sample calculations from the required EPA Method for at least one (1) sample run.

7. Restriction of Odors

If a continued situation of demonstrated nuisance odors exists in violation of 10 CSR 10-3.090 *Restriction of Emission of Odors*, the Director may require through written notice that 7th Heaven Crematory submit a corrective action plan within ten days adequate to timely and significantly mitigate the odors and 7th Heaven Crematory shall implement any such plan immediately upon its approval by the Director. Failure to either submit or implement such a plan shall be in violation of this permit.

REVIEW SUMMARY

- 7th Heaven Crematory has applied for authority to install a Southern Breeze Eliminator SB-250 incinerator. This unit was installed without obtaining a construction permit.
- Hazardous Air Pollutant (HAP) emissions are expected from the proposed equipment. All HAPs are below their respective Screen Modeling Action Level (SMAL).
- None of the New Source Performance Standards (NSPS) apply to the proposed equipment.
- None of the National Emission Standards for Hazardous Air Pollutants (NESHAPs) or currently promulgated Maximum Achievable Control Technology (MACT) regulations apply to the proposed equipment.
- A secondary firing chamber is being used to control the HAP emissions from the equipment in this permit.
- This review was conducted in accordance with Section (5) of Missouri State Rule 10 CSR 10-6.060, *Construction Permits Required*. Potential emissions of all pollutants are below de minimis levels. 10 CSR 10-6.060 paragraph (1)(B) requires all incinerators to obtain construction permits.
- This installation is located in Pettis County, an attainment area for all criteria air pollutants.
- This installation is not on the List of Named Installations [10 CSR 10-6.020(3)(B), Table 2].

- Ambient air quality modeling was not performed since potential emissions of the application are below de minimis levels.
- Emissions testing is required for the incinerator.
- A Basic Operating Permit application is required for this installation within 30 days of equipment startup.
- Approval of this permit is recommended with special conditions.

INSTALLATION DESCRIPTION

7th Heaven Crematory operates a small animal incinerator. The incinerator was installed without obtaining a permit from the Air Pollution Control Program.

No permits have been issued to 7th Heaven Crematory from the Air Pollution Control Program.

PROJECT DESCRIPTION

The incinerator is a Southern Breeze SB-250 incinerator capable of incinerating 50 pounds of pathological waste per hour.

The incinerator is permitted to burn pathological animal waste that is not considered medical/infectious waste. These terms were taken from the Code of Federal Regulations 40 CFR 60.51c. Pathological animal waste is waste material consisting of only animal remains, anatomical parts or tissue, the bags or containers used to collect and transport the waste material and animal bedding. Medical/infectious waste means any waste generated in the diagnosis, treatment or immunization of animal, in research pertaining thereto, or animal waste including contaminated animal carcasses, body parts and bedding of animals that were known to have been exposed to infectious agents during research, production of biologicals or testing of pharmaceuticals.

EMISSIONS/CONTROLS EVALUATION

Emissions calculations were taken from the application and are the same magnitude as those from other incinerators. Emissions of PM and CO will be verified through testing. Emissions of HAPs were calculated using emission factors from FIRE for SCC 5-02-005-05. Potential emissions of the application represent the potential of the new equipment, assuming continuous operation (8760 hours per year.) The following table provides an emissions summary for this project.
