On April 21, 2020, the Air Pollution Control Program received notification of an error that was found in Permit 042020-001. Special Condition 3.F.2 wording was cut-off in the final permit document. Special Condition 3.F in Permit No. 042020-001 will be superseded by the Special Condition stated in this permit correction. Please attach this correction to Permit No. 042020-001.

If you were adversely affected by this permit decision, you may be entitled to pursue an appeal before the administrative hearing commission pursuant to Sections 621.250 and 643.075.6 RSMo. To appeal, you must file a petition with the administrative hearing commission within thirty days after the date this decision was mailed or the date it was delivered, whichever date was earlier. **SPECIAL CONDITIONS:**

The permittee is authorized to construct and operate subject to the following special conditions:

*The special conditions listed in this permit were included based on the authority granted the Missouri Air Pollution Control Program by the Missouri Air Conservation Law (specifically 643.075) and by the Missouri Rules listed in Title 10, Division 10 of the Code of State Regulations (specifically 10 CSR 10-6.060). For specific details regarding conditions, see 10 CSR 10-6.060 paragraph (3)(E). "Conditions required by permitting authority."*

Stoddard County, S2/11, T25N, R10E

1. **Superseding Condition**  
The conditions of this permit supersede special condition 3.F found in the previously issued construction permit 042020-001 issued by the Air Pollution Control Program.
  
2. **LFG Sulfur Content Testing**  
Lemons Sanitary Landfill shall perform testing within 180 days after the installation starts to accept waste in the expansion area. Lemons Sanitary Landfill shall notify the Missouri Air Pollution Control Program Compliance/Enforcement Section by email at [AirComplianceReporting@dnr.mo.gov](mailto:AirComplianceReporting@dnr.mo.gov) within 30 days after accepting waste in the expansion area. Subsequent testing shall be performed according to the following schedule:
  - 1) Testing shall be continued once per quarter. No consecutive tests shall be performed within one (1) month of each other.
  
  - 2) If four (4) consecutive quarterly tests indicate a concentration not exceeding 75% of 500 ppmv (375 ppmv), then subsequent tests shall be performed once per calendar year. No two calendar year tests shall be performed within three (3) months of each other.
