Dear Mr. Reppond:

This letter is to notify you that the Missouri Department of Natural Resources (Department) received Safety-Kleen Systems, Incorporated's Class 1 Permit Modification notice, dated March 28, 2011. The notification was for updating the contingency plan information within the permit application (Appendix G., Exhibit G-2) dated September 11, 2002. Specifically, the emergency coordinator information has been updated to reflect a change in address for the emergency coordinator. Also, the St. Charles County Sheriff has been removed and the St. Peters Police added due to a jurisdictional change among these agencies.

The Department agrees with Safety-Kleen Systems, Incorporated, that this is a Class 1 Permit Modification not requiring prior director approval. Safety-Kleen Systems, Incorporated, must send a notice of the modification to everyone on their facility mailing list and the appropriate units of state and local government within 90 calendar days after the change was put into effect, as outlined in Code of Federal Regulations 40 CFR 270.42(a)(1)(ii), incorporated by reference in Code of State Regulations 10 CSR 25-7.270(1). Safety-Kleen Systems, Incorporated, must send a copy of the notice to the Department.
