Dear Mr. Duvall:

The Solid Waste Management Program (SWMP) recently received the final Independent Accountants' Report on Applying Agreed-Upon Procedures for Region L-St. Louis-Jefferson Solid Waste Management District conducted by McBride, Lock & Associates. A copy of that report is enclosed for your action.

We have reviewed the findings made by the accounting firm and the district's responses to those findings. We have prepared a list of actions (enclosed) that we recommend the district take to correct problems identified in the audit. Our recommended actions are addressed in the same order as the issues in the accountant's report. I would like to point out that the findings in this report are based on the current rule. As we work through the audit resolution process, we anticipate the final order of rulemaking will become effective (October 30, 2007). We have noted within the recommendations those areas we believe to be impacted by the rule.

As early resolution is in the best interest of the program and district, we request a meeting with the executive board and district planner to ensure these audit findings are addressed timely. We would like to reach a mutually agreeable meeting date and time for all parties, but request the meeting occur no later than 30 days from the date of this letter.

Following the audit resolution meeting, Region L's written response to the findings should be received in our office no later than 60 days from the meeting date. We will be able to review your audit resolution responses more quickly if you follow the same order as the list of recommended actions.


