<u>Fiscal Year 2015 Clean Water State Revolving Fund Intended Use Plan</u> Agenda Item #3

Doug Garrett, Financial Assistance Center presented the Draft Fiscal Year 2015 Clean Water State Revolving Fund Intended Use Plan and Priority List (IUP). Mr. Garrett noted a public hearing had been held by the Commission on July 9, 2014, and that the public comment period closed on July 16, 2014. He stated that during the public hearing the proposed project lists had been revised to include projects meeting the Commission's readiness to proceed criteria prior to the close of the public comment period. Mr. Garrett noted that as a result of comments received the City of Jefferson was removed from the Outstate Fundable Projects list and the city of Wellsville project was moved from the Outstate Fundable List to the Disadvantaged Community Reserve list. He noted that comments were also received from the U.S. Environmental Protection Agency and A Civil Group related to programmatic issues and requesting clarification on how items were presented in the IUP.

Administrative Hearing Commission's Recommended Decision for Glover Permit Appeal 07-0543 CWC Agenda Item #4

John Madras, Director of Staff, recommended the Commission table the Administrative Hearing Commission's recommended decision for the Glover Permit Appeal and take it up at a later meeting. Robert Brundage, Newman, Comley & Ruth P.C stated he agreed with tabling the decision. The Commission tabled the recommended decision.

PRESENTATIONS

Director Sara Parker Pauley, Department of Natural Resources noted that a Joint Commission meeting was held earlier in the morning between the Missouri Clean Water Commission, Safe Drinking Water Commission, Soil and Water Districts Commission, and Well Installation Board to discuss roles of the different Commissions, the Department, and the individual Programs. She stated the Commissions and Board had decided to move forward on a strategic planning process for the future and that each Commission and Board would be selecting one member to represent them on a workgroup. The workgroup members would work on how to go about putting together a strategic plan and a comprehensive water plan for water quality and quantity and bring it back to the larger group at a meeting to be scheduled in the spring. Chair Parnell noted that Commissioner Ashley McCarty would represent the Missouri Clean Water Commission on this workgroup.

Director Pauley announced that a Governor's Conference on Natural Resources is being held November 12-13, 2014 at the White River Conference Center in Springfield, MO to discuss past, present, and future challenges facing the state of Missouri. She also announced that on the afternoon of November 11th a Commission/Board training workshop is being held for all the Boards and Commissions.

Nutrient Reduction Strategy Update

Joe Engeln, Department of Natural Resources presented the draft Nutrient Reduction Strategy and explained the context and process of developing it.

Robert Brundage of Newman, Comley & Ruth P.C, representing Missouri Agri-Business and Leslie Holloway of Farm Bureau spoke in favor of the strategy. Ms. Holloway also noted many aspects of the strategy were already in progress.

Lorin Crandall of the Missouri Coalition for the Environment stated he did not believe the strategy would be successful and noted several areas that could be improved.

Roger Walker, REGFORM, stated that he applauds the leadership of Director Pauley and the Department's efforts on getting stakeholders involved in the early stages of issues and the overall balance efforts.

No action taken by the Commission.

Director's Report

John Madras, Director, Water Protection Program reported the following to the Commission:

- Thanked the Boone County Regional Sewer District and the city of Columbia for hosting a tour of the Commissioners at several of their wastewater treatment facilities on September 30th.
- The Department announced Hannah Humphrey as the Division of Environmental Quality Community Services Coordinator, and that together with regional office staff, she would focus on small cities and assist them.
- The Department will conduct a hearing on a proposed Concentrated Animal Feeding Operation in Calloway County.
- The Department is preparing to refer 28 cases to the Attorney General's Office for nonpayment of fees, twenty of which have other violations in addition to not paying fees.
- The Environmental Protection Agency has reached a decision on the impaired waters list approved earlier by the Commission. Several changes were placed on public notice.
- o The Department had revised the procedure for affordability, or the cost of compliance analysis. This is in use now and will the subject of further discussion, including a meeting December 5.
- o The water quality certification rule amendment is under development and will have a meeting October 20.
- The water quality standards rule continues under development. No draft rule is completed at this time and there have been suggestions for other additions. Several of these were discussed by those present, including sulfate/chloride and wetlands.

No action taken by the Commission.

Public Comment and Correspondence

Several individuals addressed the Commission, including:

- o Robert Brundage of Newman, Comley & Ruth P.C, and Roger Walker, REGFORM, expressed interest in proceeding with the sulfate/chloride standard.
- o Ed Galbraith, Barr Engineering, presented the city of St. Peter's invitation to the Commission to visit and review their stormwater facilities.
- O Phil Walsack, Missouri Public Utility Alliance, spoke in favor of commission tours and inquired whether the Department would be commenting on the proposed waters of the United States rule. Director Pauley responded that the Department is actively involved in the discussion of the rule through several venues and anticipates submitting comments.
- Karen Flournoy of the Environmental Protection Agency described the status of the agency's reviews of standards rules, and some specific comments on the sulfate/chloride criteria.

- o Robert Brundage and Hans Holmburg presented a request for revisions to the aquatic life standards for cadmium and lead. Jacob Westin noted that a response to the petition was needed in 60 days but the next Commission meeting was January 7, 2015, Mr. Brundage stated a response by January 7th was sufficient as far as he was concerned.
- Joseph Bachant expressed concerns about environmental concerns about Concentrated Animal Feeding Operations.
- Lorin Crandall, Missouri Coalition for the Environment, asked that we keep in mind human health aspects before making changes to the aquatic life standards for cadmium and lead.

No action was taken by the Commission.

Future Meetings

The Commission noted that the next Commission meeting is scheduled for January 7, 2015 at the Lewis and Clark State Office Building in Jefferson City beginning at 10:00 a.m.
