State Fiscal Year 2015 Clean Water State Revolving Fund Intended Use Plan Revisions

Agenda Item #3

Doug Garrett, Financial Assistance Center, presented revisions to the State Fiscal Year 2015 Clean Water State Revolving Fund Intended Use Plan (IUP). Mr. Garrett stated that the department was seeking approval to increase the Metropolitan St. Louis Sewer District, Public I/I Reduction Program – Phase III, C295023-37 project from \$30,000,000 to \$59,000,000 with a corresponding decrease in the Public I/I Reduction Program – Phase IV, C295023-38 project from \$73,000,000 to \$44,000,000. He also noted the department was seeking approval to transfer \$5 million from Clean Water State Revolving Fund repayment fund (Fund 0602) to the Drinking Water State Revolving Fund repayment fund (Fund 0602).

Leasue Meyers, Engineering Section, presented the Northeast Public Sewer District (NPSD) request for Level 2 Continuing Authority pursuant to 10 CSR 20-6.010(3)(B)(2). Ms. Meyers noted that the NPSD provides wastewater collection and treatment on a regional basis and plans to continue to implement regional collection and treatment facilities.

Commissioner McCarty made a motion to designate the Northeast Public Sewer District as continuing authority providing sewage collection and treatment service on a regional basis in their service area which is in Jefferson County. Under this designation, the Northeast Public Sewer District will provide regional services inside their service areas and in any subsequently annexed areas. Commissioner Warren seconded the motion. PRESENTATIONS

Work Plan Outline for the Missouri Water Plan

Todd Sampsell, Deputy Director of the Department of Natural Resources presented the status of the work plan to the Commission. The Commission expressed enthusiasm for the plan and noted it is one of their three priorities for this year.

Robert Brundage Newman, Comley, and Ruth inquired whether this water plan would be recommending changes to the water use laws or common law. Mr. Sampsell responded that no, it would not recommend changes to the water use law. He stated it would be making recommendations about potential water sources or recommended studies of how to address potential shortages in water issues or potential issues with water quality based on present conditions or future growth, but not changes to the water use law.

Commissioner McCarty requested that the Commissioners review the draft water plan and send any suggestions they might have to her for the joint committee.

Director's Report

John Madras, Director, Water Protection Program reported the following to the Commission:

- The affordability portion of the law has been addressed in the permitting process for several years, and is a continuing dialog with cities. This is now focused through the community services initiative. There is a stakeholder meeting to further work through the topic April 2.
- Also related to communities, the department has awarded \$1.3 million in engineering grants to cities to develop plans for upgrading systems or addressing inflow and infiltration. 37 grants have been made, and there is an additional \$950,000 to work with.
- The water quality standards rule is progressing, with some items planned for a near term rulemaking and others needing more development for a later rulemaking. The near term rule would include lake nutrient criteria, pH, some 304(a) federal criteria, general criteria, losing streams and site-specific dissolved oxygen criteria. Longer term changes may include remaining 304(a) criteria, specific criteria for sulfate, chloride, lead and cadmium, wetlands, nutrients for flowing waters update of the NHD, and other changes.
- There are eight active appeals before the Administrative Hearings Commission. The Callaway Farming appeal may be completed soon and the Clean Water Commission may schedule an interim meeting for a decision depending upon the timing and effort involved in the case. Other appeals will come before the Commission later, and staff will advise of their progress and timing.

No action taken by the Commission.

Public Comment and Correspondence

Joe Bachant presented information related to streams in the vicinity of the Callaway Farrowing permit. A discussion centered on the appropriateness of the Commission hearing such information given the ongoing appeal. The Attorney General's Office will review the information and assign legal counsel to advise the Commission.

Joe Gillman, Director, Geological Survey Division, announced that Andrea Collier had been appointed as the new Director of the Water Resources Center and Deputy Director of the Geological Survey Division.

No action was taken by the Commission.


Future Meetings
