Form(s) / invoice(s) approved for submittal as proof of vehicle mileage may be either:

- A State Safety Inspection MVI-2 Form or GVIP Vehicle Inspection Report, or **VIR** – Required for a vehicle 5 years old or older.
- A service or repair invoice from an authorized provider of that service or repair* – Allowed only if vehicle is less than 5 years old.
- An invoice from the manufacturer's authorized dealer for the make of vehicle* – Allowed only if vehicle is less than 5 years old.

* If something other than a State Safety Inspection MVI-2 Form or GVIP VIR is to be submitted, the documentation must:

- Be dated from two months or less before the vehicle's license registration renewal month.
- Be on the facility's official letterhead paper which includes the facility name, address and phone number.
- Include the Vehicle Identification Number and odometer reading at the time of the service or repair.

The Missouri Department of Natural Resources will process this emissions inspection exemption request upon receipt. Applicants will be contacted within five business days of receipt of this exemption request regarding its approval status. If approved, an emissions exemption VIR and letter documenting compliance, along with any original documents submitted, will be mailed to the address listed herein. Proof of current Emissions Exemption will also be sent electronically to the Missouri Department of Revenue.

The Missouri Department of Natural Resources is not responsible for any penalties associated with late registration due to failure to submit this exemption request in a timely or complete manner. Fraudulent or incomplete requests will not be approved.
