CAFO Annual Report Instructions

GENERAL: MOGS1 (State No-Discharge) permittees complete Parts 1-4 (except 2.8). MOG01 (NPDES) permittees complete Parts 1-7 (except 2.9). The annual report is due by February 15 for the previous calendar year. Complete a separate form for each permit number. Send only the record keeping forms that are required for the Annual Report. Liquid manure storage level readings, precipitation records, and manure transfer records do not need to be submitted.

PART 1 - PERMIT INFORMATION. This is general information for the operation and can be copied from your current permit, if it is the same. For ownership transfers or modifications submit a Form W and permit modification fee.

PART 2 – OPERATION SUMMARY INFORMATION. 2.1 – An export only operation is one that sells or transfers all generated process wastes to other parties. If any process waste is land applied on fields that are owned, rented, leased or controlled by the CAFO owner/operator, it is not an export only operation.

2.2– From the table below, enter the code for each animal category and the maximum number of animals housed under roof at any one time during the reporting period.

2.3 – Same as 2.1 except for animals in open confinement. **Do not include animals in pasture.**

2.4 – Record the amount (gallons for liquids, tons for solids) of process waste generated during the reporting period. Process waste includes manure, litter, compost (including bedding), slurry, process wastewater, mortality compost, sludge, contaminated rainwater, etc. The amount can be estimated.

2.5 – Record the amount (gallons for liquids, tons for solids) of process waste exported during the reporting period. This information is the total from Sheet 1C from the CAFO Record Keeping Forms.

2.6 – Enter the number of spreadable acres that are included in a Nutrient Management Plan (NMP).

2.7 – Enter the number of acres used for land application during the reporting period that are included in a NMP. Include only the fields that are owned, rented, leased and controlled by the CAFO owner/operator.

2.8 – **MOG01 permits only.** If any revisions were made to your NMP during the reporting period, those revisions must be submitted with the annual report if they have not already been submitted. The entire updated plan may be submitted on a compact disc with a letter identifying what revisions were made.

2.9 – **MOGS1 permits only.** Enter the date soil tests were taken that was used in development of the NMP. This is not required for export only operations. The NMP does not need to be submitted.

PART 3 – SPILLS AND OVERFLOWS. If no discharge occurred, report as No-Discharge. If yes, complete and submit Sheet 1A of CAFO Record Keeping Forms.

PART 4 - SIGNATURE. Sign and date the report.

PARTS 5 THROUGH 7 TO BE COMPLETED FOR MOG01 PERMITS ONLY

PART 5 - MANURE TESTSING RUSULTS. Include the annual manure analysis for each manure source. Testing manure for nutrient content is required for all CAFO's including those that are export only. Manure sources include, but are not limited to, multiple lagoons, deep pit, litter, mortality compost, and sludge. (Multi-cell lagoons are considered one lagoon.).

PART 6 - SOIL TESTING RESULTS. Include soil testing results that were taken during the reporting period. Soil sampling for each field in the NMP is required at minimum once every five years. This is not required for export only operations.

PART 7 - LAND APPLICATION SUMMARY BY FIELD. For fields included in a NMP, provide a summary of land application for each field that received process waste during the past twelve (12) months. Attach additional sheets as necessary. This is not required for export only operations.
