The replaced parts must be installed on the vehicle. Verification of parts installation and operation may be required by the Department of Natural Resources prior to this cost-based waiver being issued.

The Missouri Department of Natural Resources will process each request upon receipt. Applicants will be contacted within five business days of receipt of this cost-based waiver request regarding its ability to be approved. The department is not responsible for any penalties associated with late registration due to failure to submit a cost-based waiver request in a timely manner. The department reserves the right to investigate all cost-based waiver requests. Fraudulent requests will not be approved.

## **SECTION D - ADDITIONAL INFORMATION**

## **Explanation of Terms**

**Qualifying Repair** - Any repair or adjustment performed on a vehicle's emissions-control system, after failing an initial Gateway Vehicle Inspection Program emissions inspection, determined through diagnostic investigation or subsequent emissions inspection outcome as reasonable for correcting the causes of the diagnostic trouble codes (DTCs) reported on the pre-repair emissions inspection failure report.

Qualifying repairs generally resolve the cause of the DTCs reported on the pre-repair emissions inspection. Diagnostic data from both before and after the repair that documents it was effective in correcting a faulty component is one way of qualifying a repair as necessary. An after repair emissions inspection result that indicates both the appropriate emissions monitor 'Completed' and does not report the DTC the repair was made to correct is another accepted means of qualifying the repair.

For a Cost-Based Waiver for Repairs Made by a Vehicle Owner, only the costs of the qualified parts purchased and installed by the vehicle owner may be considered.
