To the Land Reclamation Board,

I'm writing out of concern about the Heartland Materials Company currently applying for a permit to operate a strip mine quarry in the immediate area of Saxony High School, and the intersection of Highway 61 and Interstate 55. I substitute teach at Saxony and also have ten grandchildren, some which may decide to attend Saxony. ----that is if it is not in the middle of a mining operation with blasting, lime dust, and the constant noise of 200 plus diesel dump trucks in constant motion from dawn to dusk!

I am concerned about the health of myself and of the students at the school as I understand that quarries generate quite a lot of dust regardless of there efforts to control it. Saxony students are active in outdoor sports and have visiting teams along with their families attending soccer and baseball games out in this open air.

I am also very concerned about the negative impact this will have on the potential growth and livelihood of this school. This school is built and maintained by an association of 25 member churches and have a multi-million dollar investment in the school, which just last year went through another \$1million addition. Having a quarry so close to our school certainly does not bode well for a new school that was built long before any quarry was proposed. This business venture to benefit one person will deter many students from choosing Saxony High School, which in itself could be a huge draw and positive economical boon to this rural area of the state, bringing growth in housing, business, parks, recreation areas, etc.

There are several other concerns about the quarry that worry us such as increased large truck traffic on narrow two-lane roads with many teen drivers and school buses to a nearby elementary school. Also, the blasting can have negative effect on homeowner's septic systems and wells which are prevalent, and concerns about pollutants entering the water table which is very near the surface in this area. (Perry County next door has karsts type)

It is not the quarry itself that is objectionable, but the area in which it is placed that presents the most problem. I respectfully ask that Saxony Lutheran High School be granted a hearing to discuss these and other matters regarding this proposed quarry adjacent to the school grounds. Currently, there are just too many unanswered questions and concerns to go any further without one. Thank you for your consideration.



We are writing to voice our opposition to the **Heartland Materials quarry** that has applied for a permit to operate in the Fruitland community. We live in-between Fruitland and Jackson and this situation affects us directly. We have serious concerns regarding this permit.

Because we know fugitive dust cannot be completely controlled in every situation, we have serious concerns about how our health will be affected. Extra irritants in the air could seriously affect our future health and daily quality of life.

This letter is in opposition to the rock quarry Heartland Minerals is seeking a permit to construct on County Road 601 in Jackson Missouri. I am sure you have seen their proposal; now here is a look at the personal view from the neighborhood side of the coin.

My husband and I purchased our property in March of 1978. We lived on the property in a mobile home until building our home in 1983. We raised our 4 children and planned to retire here. All this took place 30 years before Heartland Minerals thought about mining rock in our area.

In the past 32 years we have lived here we've made many improvements to our property. We built the house, we added a 30x30 foot detached garage years later and then added another 12 foot on to that. We payed to have the road around our property paved before the county started paving roads for dust control. We built a retaining wall along the side of our property that borders the road to prevent soil erosion. We poured a concrete drive and put a white fence around the front and side of our property. For the past few years we have spent between 25 to 30 thousand dollars remodeling the inside if our home all in preparation for retirement. We've always taken pride in our home. Never would we have put this kind of money in our home if we had known this would happen.

Many of our neighbors have been here for more than 25 years and their stories are similar to ours. They also purchased their property, built their homes, raised their children and planned to retire here.

All this was done decades before Heartland minerals came into the picture.

Our concerns are shared by many and they pertain to our way of life changing and our property values decreasing because Heartland Minerals hasn't taken into consideration the people who have lived here for years.

To begin with we are concerned with structural damage to concrete foundations, walls, and floors caused by blasting. Our insurance company has also voiced these concerns regarding what is covered and not covered in our policy.

Our community rely on wells for our water supply. We do not have county water to rely on. How will the blasting affect the quality of water we get from these wells.

There are 2 schools and several daycares close to this site. How will the dust affect the quality of air the children and residents of the neighborhood breath. We spend time outdoors with family and friends bar b queing and visiting. Our grandsons spend several days a week at our home playing outside. Will the dust change our ability to enjoy the outdoors?

Several residents on our road work swing shifts, or as in the case of my husband the overnight shift. These people sleep during the day. How will the noise from blasting, drilling, rock crushers, generators, heavy trucks and excess traffic affect the quality of sleep these people need to perform their jobs adequately and safely.

We live in a residential/farming community our roads, bridges and culverts are not reinforced to withstand the heavy and excess traffic a rock quarry will generate. With the county running on a tight budget what will happen to these roads? As in our case, we payed to have ours paved. We made this improvement with our hard earned money only now to have it destroyed by companies that were not in the picture when it was done.

As in many neighborhoods we have children riding bikes and people walking.

How will the increase in traffic affect the safety of these people? We sit in the front yard and neighbors stop by to chat. We bar-b-que and have family and friends over. Will this also change because of the noise, traffic and air quality?

There is rock quarry in this area now that has laid off all it's employees due to lack of sales and they couldn't tell the employees when they will be called back.

Just because we are a county neighborhood with no zoning regulations doesn't mean we should lose everything we have worked for and dreamed of for 32 years. We are asking you to deny blasting rights to any quarry wanting to destroy our neighborhood.

We request a informal hearing in front of the commission on this matter.

It has come to our attention that Heartland Materials has applied for a permit to operate a quarry very close to the campus of Saxony Lutheran High School. We are writing because we are most concerned about this situation and the impact a quarry would have on the ongoing livelihood of the school.

We are members of Trinity Lutheran Church, Altenburg, one of the 25 churches who together form the ownership association for Saxony.

Our concern is about the future livelihood of the school should a quarry be granted a permit to operate so close to our grounds.

Our congregation, and all congregations in the association, has a multi-million dollar investment in this school, an investment that was made for current and future students. However, we fear that the future of our school may be irreparably harmed by this proposed development. Right now we are a growing, vibrant school, but the perception of a school so close to a dusty, noisy industrial site like this one will most likely keep many students from choosing to attend Saxony. Once this happens, the growth stops and the long-term livelihood looks more bleak as each year passes and the quarry gets bigger and bigger.

Our school was located here long before this permit was applied for and so we believe we should have a chance to explain our case more fully before any decisions are final. We respectfully ask that you give Saxony Lutheran High School a hearing about this permit so that all areas of its potential impact can be discussed in a public forum, openly and honestly.

In addition, as the music director of Saxony Lutheran High School, I, Tyson Wunderlich, believe a quarry would be a huge detriment to the practice and performance of music in our school. The additional noises from blasting would interfere with the music program, not only limiting our hope of future progress, but obliterating the progress we've been able to achieve to this point.
