ORDER FOR SUBMISSION OF MEMORANDA
ON
APPLICATION PROCESS

On or before April 21, 2008, Petitioner, Joint Sewer Board, shall file with the Hearing Officer, copy to opposing Counsels, its Memorandum listing the alleged specific omissions or deficiencies in the Application filed by Applicant that are the basis for Petitioner’s Motion to Dismiss.

On or before April 21, 2008, Respondent shall file with the Hearing Officer, copy to opposing Counsels, his Memorandum listing any omissions or deficiencies in the Application filed by Applicant, and any supplemental filings of documents and/or information by Applicant to address the omissions or deficiencies, with dates any such supplemental filings were made with the Respondent. Respondent shall also list any existing omissions or deficiencies that the Applicant has not addressed, as of April 21, 2008.

On or before April 21, 2008, Applicant shall file with the Hearing Officer, copy to opposing Counsels, its Memorandum listing any omissions or deficiencies in the Application filed by Applicant which were discovered or brought to Applicant’s attention

after the initial submission of the Application, and a list of subsequent filings of documents and/or information, with dates any such supplemental filings were made with the Respondent, in response to the discovered omissions or deficiencies. Applicant shall also list any existing omissions or deficiencies the Respondent has informed Applicant have not been addressed, as of April 21, 2008.

The Memoranda hereby ordered to be filed shall not contain any suggestions in support or arguments relative to any of the matters reported. The Memoranda are to only list those items that are factual issues relative to the Application and alleged and/or real omissions or deficiencies with the Application.
