These rules are not necessary because there are no longer any applicable sources.

- \* 10 CSR 10-2.390 (rescission) Kansas City Area Transportation Conformity Requirements

This proposed rescission will remove an unnecessary regulation. The Kansas City Area Transportation Conformity Requirements rule was created to comply with federal requirements for the 1997 1-hour ozone standard maintenance area. This rule is unnecessary because the one (1)-hour ozone standard which applied to the Kansas City metropolitan area was revoked on June 5, 2005.

- \* 10 CSR 10-5.360 (rescission) Control of Emissions From Polyethylene Bag Sealing Operations

This rule is no longer necessary because the two sources subject to this rule are no longer in business.

- \* 10 CSR 10-5.520 (rescission) Control of Volatile Organic Compound Emissions From Existing Major Sources

This rule is not necessary because no sources are subject to this rule. This rule was created to help bring the St. Louis ozone nonattainment area into compliance by reducing volatile organic compounds (VOCs) from sources that were not affected by other rulemakings.

- \* 10 CSR 10-6.362 (rescission) Clean Air Interstate Rule Annual NO<sub>x</sub> Trading Program
- \* 10 CSR 10-6.364 (rescission) Clean Air Interstate Rule Seasonal NO<sub>x</sub> Trading Program

These rules are no longer necessary and have been superseded by the Cross-State Air Pollution Rule (CSAPR) annual nitrogen oxide (NO<sub>x</sub>), sulfur dioxide (SO<sub>2</sub>), and seasonal

NO<sub>x</sub> Trading Programs. These rules provided the requirements of the U.S. Environmental Protection Agency's Clean Air Interstate Rule (CAIR) establishing a national emissions banking and trading program.

- \* 10 CSR 10-2.320 (amendment) Control of Emissions From Production of Pesticides and Herbicides

This rulemaking removes the unnecessary use of restrictive words and compliance dates found in the rule and reorganizes the rule into the standard rule organization format.

- \* 10 CSR 10-2.340 (amendment) Control of Emissions From Lithographic Printing Installations

This rulemaking will remove the unnecessary use of restrictive words, update incorporation by reference information, add definitions specific to this rule, and make administrative updates. It also replaces the word installations with operations in the title for consistency with its St. Louis area counterpart rule.

- \* 10 CSR 10-5.570 (amendment) Control of Sulfur Emissions From Stationary Boilers

This rulemaking will remove the unnecessary use of restrictive words, update incorporation by reference information, add definitions specific to this rule, and make administrative updates.

- \* 10 CSR 10-6.030 (amendment) Sampling Methods for Air Pollution Sources

This rulemaking will comply with Executive Order 17-03 criteria and amend this rule to update incorporations by reference. This rulemaking will provide a more efficient way to incorporate by reference methods for stack testing as found in 40 CFR part 51, 40 CFR part 60, and 40 CFR part 61.

- \* 10 CSR 10-6.040 (amendment) Reference Methods

This rulemaking will update the incorporation by reference date to include the latest Federal Register Notices that promulgated new equivalency methods for monitoring air pollutants. Adding these monitoring methods to the rule allows entities to use them for determining compliance with National Ambient Air Quality Standards (NAAQS). Additionally, this rulemaking will update incorporations by reference, remove the unnecessary use of restrictive words, and add American Society for Testing and Material (ASTM) standards referenced in other 10 CSR 10 rules.

- \* 10 CSR 10-6.110 (amendment) Reporting Emission Data, Emission Fees, and Process Information

This rulemaking will update the applicable year(s) for the emission fee. There will be no change to the fees at this time. This rulemaking will also remove unnecessary use of restrictive words, add definitions specific to this rule, and make administrative updates.

This assures that state rule requirements remain consistent with the latest federal rule requirements to avoid confusion.

This rule as a whole establishes emission standards for sources that emit or have the potential to emit hazardous air pollutants.

- \* 10 CSR 10-6.080 (amendment) Emission Standards for Hazardous Air Pollutants

This proposed rulemaking will adopt new emission standards, updates, and clarifications to existing federal rule 40 CFR 61 that were promulgated from January 1, 2016, through July 1, 2017. The rulemaking will also update incorporations by reference, remove the unnecessary use of restrictive words, and make other clarifying changes. This rule as a whole establishes emission standards and performance criteria for new or modified sources emitting hazardous air pollutants.

- \* 10 CSR 10-6.120 (amendment) Restriction of Emissions of Lead From Specific Lead Smelter-Refinery Installations

This rulemaking will remove emission restrictions for a facility that has shutdown, update a federal secondary Maximum Achievable Control Standard, remove the unnecessary use

of restrictive words, and update incorporation by reference information.

- \* 10 CSR 10-6.130 (amendment) Controlling Emissions During Episodes of High Air Pollution Potential

This rulemaking will remove outdated, overly burdensome requirements and reaffirm the Department's authority to take necessary and appropriate actions to mitigate an episode of extremely high air pollution.

- \* 10 CSR 10-6.161 (amendment) Commercial and Industrial Solid Waste Incinerators

This rulemaking will update the incorporation by reference date to include recent changes to the federal Commercial and Industrial Solid Waste Incineration (CISWI) rule and remove unnecessary use of restrictive words, update/add incorporations by reference as applicable, and make administrative updates. The rulemaking will also add an optional production-based mercury (Hg) emission limit as an alternative to the concentration-based Hg emission limit for the waste-burning kiln subcategory. \* 10 CSR 10-2.205 (amendment) Control of Emissions From Aerospace Manufacture and Rework Facilities

\* 10 CSR 10-5.295 (amendment) Control of Emissions From Aerospace Manufacture and Rework Facilities

These amendments will eliminate redundant requirements from certain solvent handling provisions of this rule by exempting source operations regulated under the state's hazardous waste rules. This amendment will also remove unnecessary uses of restrictive words, update definitions specific to this rule, update/add incorporations by reference as applicable, and make other minor changes and numbering corrections.



- \* 10 CSR 10-2.230 (amendment) Control of Emissions From Industrial Surface Coating Operations

This amendment removes unnecessary restrictive words, adds exemptions, adds definitions, corrects test method references, removes obsolete requirements specific to sources that have closed, changes sections to the standard rule format, and makes minor clarifications and grammatical changes.

- \* 10 CSR 10-5.220 (amendment) Control of Petroleum Liquid Storage, Loading and Transfer

This rulemaking removes obsolete provisions, reduces the regulatory burden on facilities, improves consistency with the Kansas City rule 10 CSR 10-2.260 that regulates the same types of facilities, eliminates the permitting requirement for Stage I vapor recovery systems, and clarifies rule language on testing, reporting, and other items. This rulemaking also complies with Executive Order 17-03 criteria and removes any unnecessary restrictive words, adds definitions specific to the rule, and adds incorporations by reference as applicable.

- \* 10 CSR 10-5.330 (amendment) Control of Emissions From Industrial Surface Coating Operations

This amendment creates a new surface coating category for the decorative coating of foam products and establishes an appropriate emission limit for this type of surface coating operation. This amendment also removes obsolete provisions that were applicable prior to March 1, 2012, removes a reference to a rule that is being rescinded since it is duplicative of a federal rule, removes unnecessary language and use of restrictive words, adds definitions specific to this rule, changes rule language to be consistent with defined terms, and updates incorporations by reference.

- \* 10 CSR 10-6.045 (amendment) Open Burning Requirements

This rulemaking clarifies the conditions and restrictions related to open burning. Facilities and operations that under the current rule are required to obtain an open burning permit may now open burn as long as they comply with the conditions and restrictions outlined in the rule. This rulemaking also adds definitions specific to this rule.

- \* 10 CSR 10-6.060 (amendment) Construction Permits Required

This rule amendment is an extensive rewrite of the construction permit rule and makes significant changes to clarify requirements and procedures improving user friendliness and regulatory certainty. The rulemaking also adds a voluntary permit option and a general permit option, updates incorporations by reference, removes unnecessary uses of restrictive words in compliance with the Executive Order 17-03, and removes a significant amount of duplicative language.

- \* 10 CSR 10-6.062 Construction Permits By Rule

This rulemaking allows crematories and animal incinerators a more practical compliance option and modifies the restrictions on what these units are allowed to incinerate, matches federal sulfur limits on Number 2 diesel oil, removes any unnecessary restrictive words, and adds definitions specific to this rule.

\* 10 CSR 10-6.065 (amendment) Operating Permits

This rulemaking will remove the Basic State Operating Permit requirement, correct references, change the term "regulated pollutant" to "regulated air pollutant" to match the federal use of the term, and remove the requirement to have permits for certain greenhouse gas sources. This rulemaking will also comply with Executive Order 17-03 criteria and will remove any unnecessary use of restrictive words, update additional incorporation by reference information, add definitions specific to this rule, and make administrative updates.

\* 10 CSR 10-6.170 (amendment) Restriction of Particulate Matter to the Ambient Air Beyond the Premises of Origin

This amendment will remove the unnecessary use of restrictive words, restructure the rule into the standard rule organization format, and add definitions specific to this rule.

\* 10 CSR 10-6.220 (amendment) Restriction of Emission of Visible Air Contaminants

This amendment will remove the unnecessary use of restrictive words, add definitions specific to this rule, remove a requirement for Portland cement kilns to install a continuous monitoring system, update incorporations by reference, and make other changes to clarify rule language.

\* 10 CSR 10-6.261 (amendment) Control of Sulfur Dioxide Emissions

This rulemaking clarifies existing requirements for sources of SO<sub>2</sub> emissions, removes the existing Table 1, and amends requirements that are not approved in the state implementation plan. This rulemaking also will remove unnecessary restrictive words and update incorporation by reference information.

\* 10 CSR 10-6.330 (amendment) Restriction of Emissions From Batch-Type Charcoal Kilns

This amendment will remove obsolete requirements which applied during the phase-in period of this rule that ended December 31, 2005. The rule language will be clarified by consolidating related provisions currently published in separate areas of the rule, removing the unnecessary use of restrictive words, adding definitions specific to this rule, updating references to test methods, and making other minor edits.

\* 10 CSR 10-6.372 (amendment) Cross-State Air Pollution Rule Annual NO<sub>x</sub> Trading Allowance Allocations

This rulemaking will remove the unnecessary use of restrictive words, update incorporations by reference, and add definitions specific to this rule. This rule amendment will also fully transfer responsibility for the Cross-State Air Pollution Rule (CSAPR) Annual Nitrogen Oxide Trading Program requirements to Missouri rather than keeping Missouri subject to a partial Federal Implementation Plan (FIP).

- \* 10 CSR 10-6.374 (amendment) Cross-State Air Pollution Rule Ozone Season NO<sub>x</sub> Trading Allowance Allocations

This rulemaking will remove the unnecessary use of restrictive words, update incorporations by reference, and add definitions specific to this rule. This rule amendment will also fully transfer responsibility for the CSAPR Nitrogen Oxide Trading Program requirements to Missouri rather than keeping Missouri subject to a partial FIP.

- \* 10 CSR 10-6.376 (amendment) Cross-State Air Pollution Rule Annual SO<sub>2</sub> Trading Allowance Allocations

This rulemaking will remove the unnecessary use of restrictive words, update incorporations by reference, and add definitions specific to this rule. This rule amendment will also fully transfer responsibility for the CSAPR Annual Sulfur Dioxide Trading Program requirements to Missouri rather than keeping Missouri subject to a partial FIP.

- \* 10 CSR 10-6.390 (amendment) Control of NO<sub>x</sub> Emissions From Large Stationary Internal Combustion Engines

This rulemaking will add a twenty-five (25)-ton exemption for spark-ignited (SI) internal combustion (IC) engines and clarify the reporting, recordkeeping, and compliance requirements. At the same time, a list of compliance methods is being added. The Reporting and Record Keeping section of the rule is being reformatted, annual reporting submittals will be removed, the emergency standby engine exemption is being clarified, and a statement addressing excessive emissions due to startup, shutdown, and malfunction conditions is being removed for consistency with the U.S. Environmental Protection Agency (EPA) start-up, shutdown, or malfunction (SSM) policy. At the same time, this rulemaking will remove the unnecessary use of restrictive words, add definitions specific to this rule, and update incorporations by reference information.

This proposed rulemaking will remove the unnecessary use of restrictive words, clarify rule language, update incorporations by reference, and add definitions specific to this rule.

- \* 10 CSR 10-6.070 (amendment) New Source Performance Regulations

This proposed rulemaking will adopt new emission standards, updates, and clarifications to existing federal rule 40 CFR 60 that were promulgated from January 1, 2013 through March 12, 2018, and remove the unnecessary use of restrictive words. The rulemaking will also clarify the rule purpose, remove unnecessary rule language, clarify much of the remaining rule language, and present the list of incorporated federal subparts in a more user-friendly format. This rule as a whole establishes acceptable design and performance criteria for specified new or modified emission sources.

- \* 10 CSR 10-6.075 (amendment) Maximum Achievable Control Technology Regulations

This proposed rulemaking will adopt new emission standards, updates, and clarifications to existing federal rule 40 CFR 63 that were promulgated from January 1, 2016 through January 29, 2018. This rulemaking will also remove the unnecessary use of restrictive words, update incorporations by reference, and make other clarifying changes. This rule as a whole establishes emission standards for sources that emit or have the potential to emit hazardous air pollutants.

- \* 10 CSR 10-6.080 (amendment) Emission Standards for Hazardous Air Pollutants

This proposed rulemaking will adopt new emission standards, updates, and clarifications to existing federal rule 40 CFR 61 that were promulgated from January 1, 2016, through July 1, 2017. The rulemaking will also update incorporations by reference, remove the unnecessary use of restrictive words, and make other clarifying changes. This rule as a whole establishes emission standards and performance criteria for new or modified sources emitting hazardous air pollutants.

- \* 10 CSR 10-6.120 (amendment) Restriction of Emissions of Lead From Specific Lead Smelter-Refinery Installations

This rulemaking will remove emission restrictions for a facility that has shutdown, update a federal secondary Maximum Achievable Control Standard, remove the unnecessary use of restrictive words, and update incorporation by reference information.

- \* 10 CSR 10-6.130 (amendment) Controlling Emissions During Episodes of High Air Pollution Potential

This rulemaking will remove outdated, overly burdensome requirements and reaffirm the Department's authority to take necessary and appropriate actions to mitigate an episode of extremely high air pollution.

- \* 10 CSR 10-6.161 (amendment) Commercial and Industrial Solid Waste Incinerators

This rulemaking will update the incorporation by reference date to include recent changes to the federal Commercial and Industrial Solid Waste Incineration (CISWI) rule and remove unnecessary use of restrictive words, update/add incorporations by reference as applicable, and make administrative updates. The rulemaking will also add an optional production-based mercury (Hg) emission limit as an alternative to the concentration-based Hg emission limit for the waste-burning kiln subcategory. These changes will assure that state rule requirements remain consistent with the latest federal rule requirements to avoid confusion.

- \* 10 CSR 10-6.241 (amendment) Asbestos Projects—Registration, Abatement, Notification, Inspection, Demolition, and Performance Requirements

The purpose of this rulemaking is to comply with Executive Order 17-03 and related comments and will remove the unnecessary use of restrictive words, add definitions specific to this rule, update incorporate by reference information, and remove the requirement to provide a 45-day comment period for revisions to department-supplied forms. This proposed rulemaking will also add conditions for denial of asbestos registration applications and clarify requirements to receive and keep asbestos registrations. This proposed rulemaking is consistent with 643.230.1 RSMo.

- \* 10 CSR 10-6.250 (amendment) Asbestos Projects—Certification, Accreditation and Business Exemption Requirements

The purpose of this rulemaking is to comply with Executive Order 17-03 and related

comments and will remove the unnecessary use of restrictive words, add definitions specific to this rule, update incorporate by reference information, and remove the requirement to provide a 45-day comment period for revisions to department-supplied forms. This proposed rulemaking will also add conditions for denial of asbestos occupation certification applications and clarify requirements to receive and keep asbestos certifications. This proposed rulemaking is consistent with 643.230.1 RSMo.

\* 10 CSR 10-6.280 (amendment) Compliance Monitoring Usage

This rulemaking will remove an unnecessary restrictive word, correctly incorporate reference material, and update the acceptable monitoring methods for compliance certification.

\* 10 CSR 10-6.300 (amendment) Conformity of General Federal Actions to State Implementation Plans

This proposed rulemaking will remove the unnecessary use of restrictive words, add definitions specific to this rule, remove references to a rule that is being rescinded, and make other clarifying changes.

\* 10 CSR 10-6.380 (amendment) Control of NO<sub>x</sub> Emissions From Portland Cement Kilns

This proposed rulemaking will remove the unnecessary use of restrictive words, remove obsolete dates, and add definitions specific to this rule.

\* Missouri State Implementation Plan Revision- Kansas City Power and Light – Lake Road Sulfur Dioxide (SO<sub>2</sub>) National Ambient Air Quality Standard (NAAQS) Attainment Plan Revision

The purpose of this State Implementation Plan (SIP) revision is to revise requirements for the Kansas City Power and Light Generating Station - Lake Road in Buchanan County pertaining to the 1971 24-hour SO<sub>2</sub> NAAQS of 0.14 parts per million (ppm). This SIP revision consists of an Administrative Order on Consent (AOC) to allow Lake Road to switch the primary fuel from coal to natural gas for Boiler No. 6 and discontinue the requirement to blend high and medium sulfur content coal with low sulfur content coal in Boiler No. 5. This plan will be submitted to EPA.

These amendments will eliminate redundant requirements from certain solvent handling provisions of this rule by exempting source operations regulated under the state's hazardous waste rules. This amendment will also remove unnecessary uses of restrictive words, update definitions specific to this rule, update/add incorporations by reference as applicable, and make other minor changes and numbering corrections.

- \* 10 CSR 10-2.230 (amendment) Control of Emissions From Industrial Surface Coating Operations

This amendment removes unnecessary restrictive words, adds exemptions, adds definitions, corrects test method references, removes obsolete requirements specific to sources that have closed, changes sections to the standard rule format, and makes minor clarifications and grammatical changes.

- \* 10 CSR 10-5.220 (amendment) Control of Petroleum Liquid Storage, Loading and Transfer

This rulemaking removes obsolete provisions, reduces the regulatory burden on facilities, improves consistency with the Kansas City rule 10 CSR 10-2.260 that regulates the same types of facilities, eliminates the permitting requirement for Stage I vapor recovery systems, and clarifies rule language on testing, reporting, and other items. This rulemaking also complies with Executive Order 17-03 criteria and removes any unnecessary restrictive words, adds definitions specific to the rule, and adds incorporations by reference as applicable.

- \* 10 CSR 10-5.330 (amendment) Control of Emissions From Industrial Surface Coating Operations

This amendment creates a new surface coating category for the decorative coating of foam products and establishes an appropriate emission limit for this type of surface coating operation. This amendment also removes obsolete provisions that were applicable prior to March 1, 2012, removes a reference to a rule that is being rescinded since it is duplicative of a federal rule, removes unnecessary language and use of restrictive words, adds definitions specific to this rule, changes rule language to be consistent with defined terms, and updates incorporations by reference.

- \* 10 CSR 10-6.045 (amendment) Open Burning Requirements

This rulemaking clarifies the conditions and restrictions related to open burning. Facilities and operations that under the current rule are required to obtain an open burning permit may now open burn as long as they comply with the conditions and restrictions outlined in the rule. This rulemaking also adds definitions specific to this rule.

\* 10 CSR 10-6.060 (amendment) Construction Permits Required

This rule amendment is an extensive rewrite of the construction permit rule and makes significant changes to clarify requirements and procedures improving user friendliness and regulatory certainty. The rulemaking also adds a voluntary permit option and a general permit option, updates incorporations by reference, removes unnecessary uses of restrictive words in compliance with the Executive Order 17-03, and removes a significant amount of duplicative language.

\* 10 CSR 10-6.062 Construction Permits By Rule

This rulemaking allows crematories and animal incinerators a more practical compliance option and modifies the restrictions on what these units are allowed to incinerate, matches federal sulfur limits on Number 2 diesel oil, removes any unnecessary restrictive words, and adds definitions specific to this rule.

\* 10 CSR 10-6.065 (amendment) Operating Permits

This rulemaking will remove the Basic State Operating Permit requirement, correct references, change the term "regulated pollutant" to "regulated air pollutant" to match the federal use of the term, and remove the requirement to have permits for certain greenhouse gas sources. This rulemaking will also comply with Executive Order 17-03 criteria and will remove any unnecessary use of restrictive words, update additional incorporation by reference information, add definitions specific to this rule, and make administrative updates.

\* 10 CSR 10-6.170 (amendment) Restriction of Particulate Matter to the Ambient Air Beyond the Premises of Origin

This amendment will remove the unnecessary use of restrictive words, restructure the rule into the standard rule organization format, and add definitions specific to this rule.

\* 10 CSR 10-6.220 (amendment) Restriction of Emission of Visible Air Contaminants

This amendment will remove the unnecessary use of restrictive words, add definitions specific to this rule, remove a requirement for Portland cement kilns to install a continuous monitoring system, update incorporations by reference, and make other changes to clarify rule language.

\* 10 CSR 10-6.261 (amendment) Control of Sulfur Dioxide Emissions

This rulemaking clarifies existing requirements for sources of SO<sub>2</sub> emissions, removes the existing Table 1, and amends requirements that are not approved in the state implementation plan. This rulemaking also will remove unnecessary restrictive words and update incorporation by reference information.



- \* 10 CSR 10-6.330 (amendment) Restriction of Emissions From Batch-Type Charcoal Kilns

This amendment will remove obsolete requirements which applied during the phase-in period of this rule that ended December 31, 2005. The rule language will be clarified by consolidating related provisions currently published in separate areas of the rule, removing the unnecessary use of restrictive words, adding definitions specific to this rule, updating references to test methods, and making other minor edits.

- \* 10 CSR 10-6.372 (amendment) Cross-State Air Pollution Rule Annual NO<sub>x</sub> Trading Allowance Allocations

This rulemaking will remove the unnecessary use of restrictive words, update incorporations by reference, and add definitions specific to this rule. This rule amendment will also fully transfer responsibility for the Cross-State Air Pollution Rule (CSAPR) Annual Nitrogen Oxide Trading Program requirements to Missouri rather than keeping Missouri subject to a partial Federal Implementation Plan (FIP).

- \* 10 CSR 10-6.374 (amendment) Cross-State Air Pollution Rule Ozone Season NO<sub>x</sub> Trading Allowance Allocations

This rulemaking will remove the unnecessary use of restrictive words, update incorporations by reference, and add definitions specific to this rule. This rule amendment will also fully transfer responsibility for the CSAPR Nitrogen Oxide Trading Program requirements to Missouri rather than keeping Missouri subject to a partial FIP.

- \* 10 CSR 10-6.376 (amendment) Cross-State Air Pollution Rule Annual SO<sub>2</sub> Trading Allowance Allocations

This rulemaking will remove the unnecessary use of restrictive words, update incorporations by reference, and add definitions specific to this rule. This rule amendment will also fully transfer responsibility for the CSAPR Annual Sulfur Dioxide Trading Program requirements to Missouri rather than keeping Missouri subject to a partial FIP.

- \* 10 CSR 10-6.390 (amendment) Control of NO<sub>x</sub> Emissions From Large Stationary Internal Combustion Engines

This rulemaking will add a twenty-five (25)-ton exemption for spark-ignited (SI) internal combustion (IC) engines and clarify the reporting, recordkeeping, and compliance requirements. At the same time, a list of compliance methods is being added. The Reporting and Record Keeping section of the rule is being reformatted, annual reporting submittals will be removed, the emergency standby engine exemption is being clarified, and a statement addressing excessive emissions due to startup, shutdown, and malfunction conditions is being removed for consistency with the U.S. Environmental Protection Agency (EPA) start-up, shutdown, or malfunction (SSM) policy. At the same time, this rulemaking will remove the unnecessary use of restrictive words, add

definitions specific to this rule, and update incorporations by reference information.
