



**FACT SHEET
HAZMAT, INC.
DRAFT HAZARDOUS WASTE PERMIT**

The Hazmat, Inc. facility, located at 6300 Stadium Drive in Kansas City, Missouri, is a commercial hazardous waste treatment and storage facility that serves as an “in-between” facility. Hazmat, Inc. accepts a variety of hazardous waste products from other hazardous waste generators, then bulks the waste products for off-site use as fuel. Waste products that cannot be fuel blended are collected and stored until Hazmat, Inc. ships them to other permitted facilities.

Hazmat, Inc. currently is operating at the site under a Missouri Department of Natural Resources (department)-issued Missouri Hazardous Waste Management Facility Part I Permit and U.S. Environmental Protection Agency (EPA)-issued Hazardous and Solid Waste Amendments Part II Permit. On April 28, 2006, the former owner, Waste Express, submitted a permit application to the department and EPA to renew and update its existing hazardous waste permits, which were due to expire Feb. 3, 2007. The permits were continued in effect, as allowed by Code of State Regulations 10 CSR 25-7.270(1), incorporating Code of Federal Regulations 40 C.F.R. § 270.51, until the department and EPA issue or deny new hazardous waste permits. Hazmat, Inc. replaced that application with a new application, received by the department July 6, 2016.

After a thorough technical review of the permit application and other available information, the department prepared a draft Part I Permit for the Hazmat, Inc. facility. This permit allows Hazmat, Inc. to store various F-, K-, P-, and U-listed hazardous wastes, as well as ignitable, reactive, corrosive, and toxic “characteristic” hazardous wastes in containers. The permitted hazardous waste management units consist of six container storage areas. This permit also contains contingent corrective-action conditions to address any newly-identified releases to the environment from previously- or newly-identified Solid Waste Management Units and Areas of Concern. EPA is preparing a draft Part II Permit and will make it available when it is ready for public review and comment.

The department invites the public to review and offer written comments on the draft permit from Aug. 30, 2020 until Oct. 14, 2020. During the public comment period, anyone can request a public meeting or public hearing about the draft permit. Comments on the draft permit are more helpful if they point out legal or technical issues, or provide information that is not in the record. At the end of the public comment period, the department will review all written comments and any comments given at the public hearing, if one was held. Written comments and oral public hearing testimony are treated with equal consideration. We can change or deny the final permit based on technical or legal issues brought up by the comments. We will write a summary and response to all comments and explain how each was addressed in making a final decision regarding the permit. The department will issue a final decision only after the public comment period has ended, all comments have been reviewed and written responses have been prepared to address the comments.

You may call or write the department at any time to request to have your name placed on Hazmat, Inc.'s facility mailing list. You will receive written notice from the department or Hazmat, Inc. on any major permitting and cleanup activities at the facility.
