Dear Mr. Meyr:

The Missouri Department of Natural Resources (Department) received, and hereby approves, Lone Star Industries, Incorporated's (Lone Star) Class 1 Permit Modification, dated August 29, 2016. The modification was to repair a potential leak and replace the agitator on storage tank number 2. Due to the shutdown of the tank, and past practices, Lone Star will also be modifying some of the piping layout, with additional valves and flanges, to allow for increased efficiency during these types of shutdowns. These additions will change Lone Star's Subpart BB inspection content; a regulatory requirement typically requiring a Class 2 Permit Modification. Because Lone Star performs these shutdowns on a frequent basis and the changes to the Subpart BB inspection content are very minimal, the Department and Lone Star have agreed that these changes shall be managed with a Class 1 Permit Modification requiring prior Director approval. Lone Star shall also supply an updated inspection checklist and piping layout drawings for Departmental review within 90 calendar days after the changes have been made.

Lone Star must send a notice of this modification to everyone on their facility mailing list and the appropriate units of state and local government within 90 calendar days after the change is put into effect, as outlined in Code of State Regulations 10 CSR 25-7.270(1) incorporating the Code of Federal Regulations 40 CFR 270.42(a)(1)(ii). Lone Star must send a copy of the notice to the Department.
