Dear Mr. Zoghby:

The Missouri Department of Natural Resources (Department) received EBV Explosives Environmental Company's (EBV) Class 1 Permit Modification notice, dated March 22, 2017. The notification was for the updating of the Rotary Kiln Incinerator hazardous waste feed rate found in EBV's Missouri Hazardous Waste Management Facility (MHWMF) Part I Permit, Special Permit Condition III.B.1.

The Department agrees with EBV that this is a Class 1 Permit Modification not requiring prior director approval, according to EBV's MHWMF Part I Permit, Special Permit Conditions III.B. The approval of this increase in feed rate is subject to the requirements of 40 CFR Part 63 Subpart EEE and review and approval from the Air Pollution Control Program. EBV must send a notice of the modification to everyone on their facility mailing list and the appropriate units of state and local government within 90 calendar days after the change was put into effect, according to 10 CSR 25-7.270(1), which incorporates 40 CFR 270.42(a)(1)(ii). EBV must send a copy of the notice to the Department.
