4. Written description of diagnostic test(s) performed to determine cause of diagnostic trouble code. Include the technician's reference source of the diagnostic process used. (ALLDATA®, Mitchell On Demand™, Manufacturer, etc.)			
5. Description of the components / systems tested and the test results, including those that support the qualified repair.			
6. Itemized description of the qualified part(s) determined necessary to correct the cause of the diagnostic trouble code listed and The costs to the motorist.			
7. Estimated labor costs listed separately from estimated qualified parts costs.			
8. Status of readiness (emissions) monitors when vehicle was returned to the motorist.			
9. Acknowledgement of payment for the diagnostic work performed.

#### SECTION D – ADDITIONAL INFORMATION

**Estimate-Based Waiver** – An application for an Estimate Based Waiver requires:

- The vehicle's most recent emission inspection report indicates a single \* diagnostic trouble code, or DTC.
- The same inspection report indicates a MIL-KOEO: Pass, OBD Communications: Pass, and Readiness Result: Pass
- The single DTC was not reported on the prior year's emissions inspection for registration purposes report, for which a Cost-Based Waiver or Estimate-Based Waiver was approved, without the single DTC documented as repaired for Diagnostic work, following manufacturer diagnostic processes, has been done to determine the cause of the DTC, and is explained in full on a write-up obtained from the diagnostic shop
- The diagnostic facility's determined cost of correcting the cause of the DTC exceeds \$450

\* An exception to the single DTC requirement is when diagnostic testing determines two DTCs have the same cause.

#### Explanation of Terms

**Missouri Recognized Repair Technician** - Any person who:

1. Is professionally engaged full-time in vehicle repair or employed by an ongoing business whose purpose is vehicle repair. A Missouri Recognized Repair Technician may only be recognized by the department at one place of employment.
2. Has valid and current certifications from the National Institute for Automotive Service Excellence in Electrical Systems (A6), Engine Performance (A8), and Advanced Engine Performance Specialist (L1).

**Recognized Labor Costs** - The labor costs that a Missouri Recognized Repair Technician charges for emissions repair services performed on a vehicle that fails its emissions inspection.

**Qualifying Repair** - Any repair or adjustment performed on a vehicle's emissions-control system, after failing an initial emissions inspection, reasonable for the testing failure. Repairs performed by a repair technician that were not authorized by the vehicle owner's signature on a repair receipt will not be considered a qualifying repair. The qualifying repair must be performed within 90 days of the date of initial emissions inspection. The qualifying repair may consist of either:

1. The parts costs, purchased by a vehicle owner or charged to a vehicle owner by a repair technician, appropriate for the type of emissions inspection failure.

or

2. The parts and recognized labor costs, charged to a vehicle owner by a Missouri Recognized Repair Technician, appropriate for the type of emissions inspection failure.
