A vehicle registered in the county of Franklin, Jefferson, St. Charles, St. Louis or the city of St. Louis, for which an emissions inspection is required for registration renewal in this calendar year, may qualify for an "Out-of-Area" waiver from the emissions inspection provided the vehicle: 1) is currently located and being driven in the State of Missouri; and, 2) will be operated exclusively outside of the five-county emission requirement area for the next 24 months.

The Missouri Department of Natural Resources will contact applicants within five business days of receipt of an out-of-area waiver request regarding its ability to be approved. If approved, an "Out-of-Area Waiver: Approval" vehicle inspection report and an inspection waiver decal (to be attached to the vehicle's windshield) will be sent. If denied, you will be notified by phone and mail, and must get the vehicle emissions inspected to comply with registration requirements.

The department reserves the right to investigate all "Out-of-Area Waiver" requests, and may require additional information documenting eligibility to be submitted. The department is not responsible for any penalties associated with late registration due to either failure to submit an "Out-of-Area Waiver" request in a timely manner or a delay in the request determination while an investigation is occurring. Fraudulent requests will not be honored. Vehicles documented as operating in the five county emission requirement area after approval of an "Out-of-Area Waiver" may have their registration revoked.

This form is **not to be used for vehicles located outside the State of Missouri**. Visit dor.mo.gov for information regarding inspection compliance requirements for such a vehicle, and if applicable to you, use DOR Form 768 – General Affidavit, Item # 3.
